5.0 Presentations: Opioid Misuse Windsor-Essex

5.1 Opioid Misuse in Windsor-Essex, Dr. Wajid Ahmed, Associate Medical Officer of Health

Dr. Wajid Ahmed provided a presentation to the Board on Opioid Misuse in Windsor-Essex and the harm associated. Opioids are a family of drugs primarily prescribed when other medications prove ineffective, and act on the nervous system to relieve pain. Some of these drugs are known as Oxycontin, Vicodin, Codeine, Morphine and

Fentanyl, as well as illegal drugs such as heroin. Opioid related emergency room visits, hospitalization and deaths are higher in Windsor-Essex compared to other areas of Ontario and the country, and the trend continues to increase. There were 43 related deaths in our region in 2015. We are hoping to obtain updated 2016 data sometime in May 2017.

As a public health unit our scope and mandate differ from treatment centres. Our role focuses primarily around the following:

- Health Assessment and Surveillance
- Health Promotion and Health Protection
- Increasing awareness, i.e., Patch for Patch Program and the distribution of Naloxone kits

The WECHU have been in discussions with various community partners (EMS, Police, Windsor Regional Hospital) to share and identify data to understand misuse and to identify high level objectives. Although physicians are aware of the problems that may occur in prescribing opioids, prescriptions move through the OHIP process, and these drugs are being monitored closely by the Ministry.

Negative health consequences and increasing costs to the community in emergency care, law enforcement and substance abuse treatment, is a significant problem and we do not see this issue being resolved quickly or easily.
