1.0 Call to Order

With quorum officially met, Board Chair, Gary McNamara, called the meeting to order at 4:00 p.m.

5.0 Presentations

5.1 Windsor-Essex County Health Unit – Recipient of the Bright Lights Award from the Association of Family Health Teams of Ontario – (N. Dupuis)

N. Dupuis presented WECHU's Bright Lights Award plaque to Board Chair, G. McNamara and introduced various staff instrumental in this achievement. The WECHU was the only public health unit nominated for, and the recipient of, an award at this event.

G. McNamara noted the WECHU is a driving force within the community, the region and across the province. On behalf of the Board of Health, he sincerely thanked staff for their efforts and congratulated them on this accomplishment.

5.2 Opioid Forums held in Windsor and Leamington (Dr. W. Ahmed)
Dr. W. Ahmed provided an update on the Opioid forums recently held in Windsor and Leamington. Discussions took place on real issues with strong feedback from attendees with first hand experiences.

The Windsor-Essex Community Opioid Strategy has adopted a Four Pillar structural model which will be used as the basis for a comprehensive community approach:

- 1) Prevention and Education
- 2) Harm Reduction
- 3) Treatment and Recovery
- 4) Enforcement and Justice

Information from the forums will be gathered and a final strategy will be released in January 2018. The information strategy will be shared with the community, but will just be the first step in this initiative.

Opioid addiction is increasing with opioid and fentanyl related deaths surpassing motor vehicle accidents. Opioids are generally prescribed for chronic pain and that is why they exist. Hopefully our strategies will change how we deal with pain management, i.e. physical therapy and other treatments for pain without the use of opioids.

Board Member Bill Marra noted that there are many other issues that fall outside the scope of health units, but treatment is key. Resources are starting to flow in, but it is still at the starting point. Collaboration with various agencies is critical to help eliminate the overlap of funding

8.0 Business Arising

8.1 Board of Health 2017 Competency Based Self-Evaluation Report (K. McBeth)
The purpose of the Board of Health Competency Based Survey is to identify the
strengths of the Board and opportunities for training and support. (Administration
introduced WECHU staff member, Ashley Kirby, who played a pivotal role in the
survey).

The 12 competencies and related questions are based on the Ontario Public Health Standards, Board of Health By-laws, and the alPHa Board of Health Governance Toolkit. The Board is required to conduct a self-evaluation survey annually.

Two to four questions were asked for each of the 12 competency and average scores were created for each. Satisfactory range notes that Board members have the necessary competencies to successfully complete tasks related to the topic, but assistance from an expert may be required at times. Optimal range notes that Board members, on average, are able to function most effectively and are able to perform to these competencies without expert assistance.

Administration presented the results of the report and noted the following:

- 100% Board participation in the Self-Evaluation
- Time served on the Board of Health ranged from 2 to 19 years with an average of 5.5 years
- 9 out of 12 competencies sat between the Satisfactory and Optimal ranges
- Leadership and Governance, in the Optimal range, was the strongest skill set
- The lowest, at 53%, is the makeup of Diversity (need to recruit more women and visible minorities – Chair, G. McNamara noted that the province is leaning toward more diversity – since 50% of BOH members are Provincial appointees, this is something we need to look at based on the needs of our community)

The following suggestions were made to support Board decision making:

- Additional training and support to move the Board of Health into the Satisfactory range in areas of:
 - Public Health Programs and Services
 - Health Equity
 - Legal Responsibilities
- Formal orientation of new Board of Health members to public health programs and services
- Integrate Strategic Plan and priorities into board decision making
- Report on the monitoring of the Strategic Plan's process
- Continue with topical presentations and Board of Health Summer Education Sessions, since they have proven effective
- Incorporate Best Practices from other health units

Individual competency reports can be sent to each member and will not be shared. Board members can request their individual report from K. McBeth.
