6.0 Presentations:

6.1) Topical Issues: Influenza (Wajid Ahmed, WECHU, Associate MOH)

Dr. Wajid Ahmed presented on Influenza, the strains, how it spreads and noted peak times of the year for outbreaks. Dr. Ahmed discussed how to protect yourself from Influenza by using hand sanitizers, receiving the flu vaccine and by hand-washing. New vaccines are produced each year based on the circulating strain of the virus and, as Influenza can happen at any time during the year, receiving immunization in the middle of the season can still protect you after flu season has passed. Influenza can be more severe, even fatal, for seniors and the elderly causing outbreaks in long-term care facilities, hospitalization, and creating more stress on health care workers.

The Health Unit plays a role in prevention by sending out messaging and reminders for flu vaccines, scheduling vaccination clinics for the community, and distributing the vaccine. The Health Unit works closely with long-term care facilities to monitor and help manage outbreaks and ensure protocols are in place for proper treatment. It was moved

Nicole Dupuis provided information, highlights, key findings and significant barriers on the LDCP project that the WECHU is currently leading, i.e. "Assessing Child and Youth Surveillance Gaps for Ontario Public Health Units". The goal of this particular project is to determine current practices, identify gaps, and explore novel approaches in regards to the collection, analysis, and reporting of local health status for school-age children and youth (Grades 1-12). The project is based on public health led research, and funded through Public Health Ontario.
